### STATEMENT OF GROUNDS

The overall positive assessment of the IQAS DESIGN is based on compliance with the criteria associated with each of the guidelines of the AUDIT programme, with special mention being made of the following strong points:

#### Strong points of a core nature

- In general, the existence is established of bodies with the capacity to manage the different aspects associated with each procedure.
- The level of detail of the documentary design is positively assessed, especially the section on evidence, which will assist implementation of the system.
- In general, the system for the review and enhancement of all of the processes.

### Specific strong points:

- Existence of a body/bodies with the capacity to manage the IQAS, together with each aspect covered in the guidelines of the AUDIT programme.
- Presence of systems to gather and analyse information for assessing how programmes of study that are offered are maintained, updated and renewed, and to carry out decision-making in and the monitoring, review and enhancement of matters connected with academic staff and teaching support staff.
- Presence of procedures whereby the stakeholders are kept informed.

## ENHANCEMENT PROPOSALS

In order to ensure adequate implementation of the system, the following recommendations are made:

- It is recommended that the School adapts the general system its own particular characteristics and identifies its particular committees involved in the associated processes.
- Specify the way in which the stakeholders are involved in the processes of measuring, analysing and enhancing the labour market outcomes.
- Specify the accountability procedures in relation to the labour market outcomes.
- Document the relation between the different processes presented (for example, include a process map or identify the inter-related processes in the documentation).
- Specify the composition of the academic committee.
